To whom it may concern,

The representative/owner of any and all firearms that will be auctioned by McLemore Auction Company, LLC shall deliver any and all auctioned firearms to APPS located at **1161 Murfreesboro Pike, Suite 150 Nashville Tennessee 37217**. APPS shall at that time enter any and all firearms delivered or received to APPS in their FFL books as required by Federal Law. An inventory of the firearms shall be made at the time of delivery and such inventory copies shall be given to the representative of McLemore Auction Company, LLC. The Academy of Personal Protection and Security (D.B.A. A.P.P.S), and its employees and or agents shall not be responsible for any damage/theft/destruction to any of the firearms left in their possession.

**FIREARMS SHALL "NOT" BE READY FOR TRANSFER UNTIL AUCTION IS COMPLETE!  
BUYER "MUST" ALSO CALL FOR APPOINTMENT FOR TRANSFER OF FIREARMS!**

A **NON-REFUNDABLE** fee of **\$45.00** shall be paid in cash, money order or debit card (credit and debit cards have a 3% user fee attached), this fee shall be paid in **ADVANCE** and will not be returned if the registered buyer or firearm does not pass the background check. If the buyer purchases more than one firearm the cost will be **\$45.00** for the first gun and **\$10.00** for each additional firearm. Any firearm left at APPS for over five (5) working days past date of auction, the purchaser will pay two (\$2.00) per day storage for the firearm(s) left in the care of APPS. If the registered buyer cannot pass the background check, the firearms shall be kept in possession of APPS and resold at the next appropriate McLemore Auction Company, LLC auction or disposed of at McLemore Auction Company, LLC legal discretion. It shall be the registered buyer's responsibility to contact McLemore Auction Company, LLC about the fees on the firearms. There are no refunds if buyer fails background check.

**APPOINTMENTS MUST BE MADE WITH APPS TO VIEW THE FIREARMS BEFORE THE AUCTION!**

## **IMPORTANT PLEASE READ AND SIGN!**

*The registered auction buyer is the **ONLY** person that can receive the firearm(s) purchased.*

*No relative, friend, or any other person can receive/pick up the firearm(s).*

*All purchasers of any firearm(s) **MUST** have this signed agreement and paid receipt from McLemore Auction Company, LLC in their possession to be able to pick up or transfer any firearm. If you are from out of state (Non-Tennessee Resident) you cannot receive a handgun in Tennessee. The handgun shall be shipped/delivered to an FFL dealer of your choosing in the state of your residency. If the firearm is a long gun you may receive it from APPS at the above address. You **MUST** have a valid government issued identification (valid driver's license) to pick up any firearm.*

*Purchaser must have printed receipt proof of purchase from McLemore Auction Company, LLC to pick up any firearm. Shipping of any amount along with the transfer fees shall be the responsibility of the purchaser. All fees **MUST** be paid before shipping.*
